# Where strategic cases are coming from

- Strategic thinking
- From victims to problems and cases (victim comes with a problem, we build a case):
  - Clients (Bugrova; from the web Mihailova)
  - Friends (Arbuzova, Minin)
  - Colleagues (Bahrah)
- From problems and cases to victims (we see a problem and look for a victim)
  - Victims could be ourselves (Burkov v. Russia)
- From one case to another and more (tree of cases)

## Strategic cases

- Zaharkin v. Russia (application in Borisov v. Russia)
- Bugrova v. Russia (criminal case, challenging inaction; challenging normative acts; challenging lack of standing)
- Mihailova v. Russia
- Burkov (and Lifaev, and others) v. Russia
- Burkov v. Russian Government (unemployment led to challenging normative act of Government)
- Network of cases on domestication of the Convention (Russian Labor Party, Mihailova, Bugrova, Burkov and others v. Russia)
- Cases on non-execution of domestic judgments (Constitutional Court case; ECHR; testing effectiveness of on Compensation Act)
